Process



May/June 2018	Final School Safety Team (SST) meetings focused on annual trends and patterns, assignment of ratings on self-assessment.
June 2018	State releases guidance documents on determining grades, opens web-based system.
July 2018	Submission of school self-assessment summary reports for district review.
August 23, 2018	Presentation of school reports, public comment, and board approval.
Oct. 31, 2018	Required submission of statement of assurances and school reports.
TBD	Grade assignment by Commissioner for schools and district.
Within 10 days of Grade Release	Posting of grades to district and school websites.
After Grades Received	Board of Education Meeting to review grades.
