

## **ECC and Remote Learning Care**

### **Frequently Asked Questions:**

#### **Will you accept ECC/Remote Learning Care registrations after August 30<sup>th</sup>?**

Yes, we will continue accepting registrations for ECC and Remote Learning Care until spaces are full

#### **Who can register for Remote Learning Care?**

Any child (K-5<sup>th</sup>) that attends one of the ETSD elementary schools and only on days they are not scheduled for in-person instruction.

#### **What is the Capacity in ECC and Remote Learning Care?**

ECC Capacity is 40 children max at each location

Remote Learning Care is 20 children max at each location

#### **What is the ratio for ECC and Remote Learning Care?**

Ratio is 10 students per 1 adult in both programs

#### **Will ECC be following social distance guidelines?**

Yes, the same guidelines will be followed as they are in school

#### **Will the kids have to wear masks?**

Yes, all staff and children must wear masks. Breaks will be given outside with social distancing in place

#### **Will my child's temperature be checked before ECC?**

Yes, ECC staff will be checking children's temperature every day

#### **Will spaces be cleaned before use of ECC?**

Yes, all areas will be cleaned before and after ECC and Remote Learning Care uses the space

#### **Will ECC children get to go outside?**

Yes, our goal is to get the children outside every day as much as possible. They may not always get to use the playground equipment. Only one group can use the equipment per ECC afternoon. A schedule will be made by the site supervisor that allows groups to rotate on certain days for the playground. Other outdoor space and activities will be provided on days they do not get to use the playground.

**What activities will my child do inside?**

The ECC staff are planning activities that allow for social distancing as much as possible. Children will have their own materials to use during ECC. These materials will be cleaned each day after use.

Crafts and games will be planned. Outdoor activities will be planned. Homework time will be provided.

Children will be permitted to bring belongings from home (with parent permission, of course). It must fit in their backpack. The children will be responsible for what they bring. ECC cannot be held responsible for lost or damaged items. They are not permitted to use cell phones. Ipads and gaming devices are permitted, but they must use headphones and it must be age appropriate. Internet is not available.

**Do I pack snacks/lunch for my child?**

Yes, please pack snacks and water for your child during ECC hours. For Remote Learning Care, in addition to snacks and water, please provide a lunch. They will not be permitted to get lunch from the cafeteria.

ECC will no longer be providing snacks.

**What will my child be doing during the Remote Learning Care?**

During the before and after school hours, ECC staff will provide activities, similar to regular ECC. During the actual school day, your child is responsible for “plugging in” with their teacher and following along with the teachers directions for the day. Lunch time and recess time will be included. Chrome books will be provided.

**What are the Remote Learning Care staff responsibilities?**

The staff will be there to assist your child, but are not the teachers. They will help your child with technology difficulties, if needed. They will also oversee the day and arrange breaks, lunch and recess.
